## Georgia women lawyers meet Supreme Court justices

Members of the [Georgia Association of Women Lawyers](#) traveled to Washington last week to be sworn in as members of the U.S. Supreme Court. During an open session, Chief Justice John Roberts granted the delegation admission. The group, led by Georgia Supreme Court Chief Justice Carol W. Hunstein, then met with Justices Clarence Thomas and Ruth Bader Ginsburg.

"We are grateful to Chief Justice Hunstein to create this unique opportunity for our GAWL members, and truly honored that U.S. Supreme Court Justices Ginsburg and Thomas were willing to personally meet with them on this – for GAWL – historic occasion," Amy Quackenboss, president of GAWL, said in a statement released on Friday.

The trip to Washington to be sworn in at the Supreme Court is a semi-annual tradition the association started in 2008.


